Motion by Stubenrauch supported by Turnquist and unanimously carried to approve the agenda with the addition of authorization of paying the ADA equipment bill from Capital Outlay under New Business.

The minutes of November 19th meeting stood as read.

The Sheriff's report was received.

Representatives from Michigan Works were at the meeting to present Phyllis Latvala a plaque in honor of her being named Michigan Works Alumnus of the Year for 2008.

Motion by Langdon supported by Eckloff to adopt the MERS resolution (FAC 3) to change the retirement benefits of the following elected officials: Clerk, Treasurer, Probate Judge, Prosecutor, and Mine Inspector. The change involves making a new division for these elected officials and it will base retirement on the final three years of wages instead of the final five years.
