OFFICIAL PROCEEDINGS KEWEENAW COUNTY BOARD OF COMMISSIONERS November 13, 2018

The regular monthly meeting of the Keweenaw County Board of Commissioners was held on November 13, 2018, 6:30 p.m. at the Courthouse, Eagle River, MI and began with the pledge of allegiance. This meeting is now the combination of the Keweenaw Mountain Lodge meeting and the regular Board meeting.

Commissioners present: Bob DeMarois, Sandy Gayk, Jim Vivian, Del Rajala, Don Piche.

Motion by Gayk supported by DeMarois and unanimously carried to approve the agenda as presented.

Motion by Rajala supported by Gayk and unanimously carried to approve the minutes from the October 17, 2018 regular monthly meeting as written.

The Treasurer, Sheriff, and Mine Inspector reports were received.

Time was allowed for public comment.

Motion by Vivian supported by DeMarois and unanimously carried to pay in the amount of \$4,688.82 to the Keweenaw County Road Commission bill from last month after getting clarification. The bill was for some welding at Mt Horace Greeley and for equipment removal from the Keweenaw Mountain Lodge to the Courthouse. The Road Commission agreed to put a curb in front of the Courthouse and Sheriff Department next spring as the new pavement ended up much lower than the old pavement leaving the old brick on the fence exposed.

Motion by Vivian supported by Gayk carried to accept the quote from Wards for a front mount 72" snowblower for the Kubota that was acquired from the Keweenaw Mountain Lodge in the amount of \$7,802.55 and to also have Ward's change the oils and the filters once the tractor is transported there. Board polled. Ayes: DeMarois, Gayk, Vivian, Rajala, Piche. Nayes: None. Motion carried.

Motion by Gayk supported by Rajala and unanimously carried to choose the county logo that has a circle with trees and water, with Keweenaw County printed across it and organized in 1861 over the top of the circle to use on the website.

Motion by Vivian supported by Rajala and unanimously carried approve the Shorewaves contract retroactive to November 1, 2018 at \$150 per antenna per month and to put the deadline to accept or reject the contract by December 1, 2018.

Motion by Gayk supported by Rajala and unanimously carried to set the Keweenaw County Recreation Plan Public Hearing on December 19, 2018 at 6:00 p.m. at the Courthouse.

Motion by Gayk supported by Rajala and unanimously carried to set the Public Hearing for December 19, 2018 at 6:15 p.m. for the 2019 County Budget Adoption.

Motion by Rajala supported by Gayk and unanimously carried to approve the Change Order from OHM regarding the Courthouse lighting project by the amount of \$200 for the ceiling tiles in the Equalization Department.
