Motion by Keith supported by Eckloff and unanimously carried to approve the agenda with the following additions and correction: Under New Business, 12 e) Approval of list of names randomly selected to receive grant funds for Housing Rehabilitation; 12 f) Letter of support for the Keweenaw County Road Commission's project list; 12 g) Use of Courthouse for historical presentation; 12 h) Support for Ted Johnson's application for stimulus money. Correction under New Business 12 d) UPCCA should read UPACC Spring Conference.

WHEREAS, Keweenaw County is interested in the continuing effort to provide affordable housing opportunities for low and moderate income residents;

WHEREAS, Keweenaw County has reviewed and understands the contents of the application for funding; and WHEREAS, Keweenaw County Board of Commissioners has decided to apply for a \$250,000 MSHDA Rehabilitation Program Grant, and

WHEREAS, Keweenaw County Board of Commissioners authorized the Chairman to sign the application form as required;

NOW THEREFORE BE IT RESOLVED, Keweenaw County Board of Commissioners authorized Northern Consultants, Inc. to prepare and submit the application for funding through the Michigan State Housing Development Authority's Office of Community Development.
