OFFICIAL PROCEEDINGS KEWEENAW COUNTY BOARD OF COMMISSIONERS ORGANIZATIONAL/REGULAR MEETING January 15, 2020

The organizational/regular meeting of the Keweenaw County Board of Commissioners held on January 15, 2020 beginning at 6:30 p.m., at the Courthouse, Eagle River, MI opened with the Pledge of Allegiance.

The meeting was posted on the door of the Courthouse and on the County website.

Commissioners present: Bob DeMarois, Sandy Gayk, Jim Vivian, Don Piche. Absent: Del Rajala.

The organizational meeting was called to order by the Clerk. Clerk opened nominations for the Chairman. Gayk nominated Piche for Chairman which was supported by Vivian. Clerk asked for further nominations and there being none, motion by Gayk supported by Vivian to cast a unanimous ballot for Piche as Chairman for 2020. Chairman Piche took over leading the meeting.

Chairman Piche opened the floor for nominations for Vice Chairman. DeMarois nominated Gayk for Vice Chairman which was supported by Vivian. Piche asked for further nominations and there being none, motion by DeMarois supported by Vivian to cast a unanimous ballot for Gayk as Vice Chairman for 2020.

Motion by Gayk supported by DeMarois and unanimously carried to keep the current schedule of Board meetings on the 3rd Wednesday of each month. The regular monthly Board of Commissioners meetings will begin at 6:30 p.m.

Motion by DeMarois supported by Gayk and unanimously carried to designate the following as depositories for County funds: IncredibleBank, Range, Superior National and Huntington Banks.

Motion by Gayk supported by DeMarois and unanimously carried to accept the agenda with one addition under New Business d) Resolution for recognition of Ricky Thomas as Custodian/Magistrate for 34 years of service to Keweenaw County.

Motion by DeMarios supported by Gayk and unanimously carried to approve the December 18, 2019 regular monthly meeting minutes as written.

The following reports were available: Sheriff, Treasurer and Mine Inspector.

Joe Foster from Crampton Surveying was present to update the Board on the Survey and Remonumentation program. The State is requiring a revised plan and Joe will come back before the Board in February with the updated plan for approval. The Survey and Remon program is funded by Register of Deeds recordings with \$4 of each recorded document going to this program. In Keweenaw County, there are about 2,600 land corners with about 46% of those being on Isle Royale. The program will not be concentrating on Isle Royale but will stay on the mainland.

Time was allowed for public comment. Justin Kasite spoke to the Board about the Second Amendment and requested that the Board consider the resolution that he provided to them regarding the county being a "Second Amendment Sanctuary".

Motion by DeMarois supported by Gayk to pay the approved and audited bills in the following amounts; General Fund=\$228,724.26 Construction Codes Fund=\$1,528.96 911 Fund=\$5,657.75 Veterans Affairs=\$177.52 Medical Care Fund=\$1,000.80 Board polled. Ayes: DeMarois, Gayk, Vivian, Piche. Nayes: None. Motion carried.

Motion by Gayk supported by DeMarois and unanimously carried to set the 2020 mileage rate at \$.57.

Motion by Gayk supported by DeMarois and unanimously carried to appoint Frank Kastelic to the ZBA as an alternate to replace John Wilhelm with term expiring 12/31/2020.

Motion by Gayk supported by DeMarois and unanimously carried to allow Ann Gasperich to use a flexible schedule for the day of or the day after a meeting, nothing beyond the day of or the day after. Per diems will be eliminated. The Board of Commissioner meetings are not included in this flexibility, only the following meetings are to be exchanged: 911 meetings, ZBA and Planning Commission meetings.

Motion by Gayk supported by Vivian and unanimously carried to approve the following resolution: A RESOLUTION of the BOARD OF COMMISSIONERS FOR KEWEENAW COUNTY
