Motion by DeMarois supported by Eckloff and unanimously carried to reappoint the following members to the Construction Codes Board of Appeals for a two-year term ending 12/31/2022; Eric Bjorn, Harry Herman, John Cima and Greg Kingstrom.

Motion by Rajala supported by Vivian and unanimously carried to approve the Electrical Inspector Position Description and to move forward with the advertising and with the hiring process.
