The organizational meeting of the Keweenaw County Board of Commissioners was held January 7, 2009 at 6:30 p.m. at the Courthouse, Eagle River.

The clerk opened the meeting calling for nominations for a temporary chairman. Stubenrauch seconded by Keith nominated Eckloff. There being no further nominations, Eckloff was elected temporary chairman.

Eckloff called for nominations for chairman. Eckloff, seconded by Stubenrauch, nominated Joe Langdon. Nominations being closed, all aye votes were cast. Langdon duly elected chairman

Langdon called for nominations for vice-chairman. Langdon, seconded by Eckloff, nominated Stubenrauch. A unanimous ballot was cast for Stubenrauch. Stubenrauch duly elected vice-chairman.

Motion by Eckloff supported by Stubenrauch to name River Valley, Range, Superior National, Citizens and North Country banks as depositories for Keweenaw County funds. Board polled: Ayes: Eckloff, Stubenrauch, Keith, Fouts, Langdon. Nayes: None. Motion carried.

Motion by Keith supported by Eckloff and unanimously carried to approve the agenda with the addition of KEDA dues under New Business, item (c).

Motion by Stubenrauch supported by Eckloff and unanimously carried to approve the minutes of the December 17<sup>th</sup> public hearings and the December 17<sup>th</sup> official meeting as presented and to forgo the clerk's reading of those minutes at this official meeting.

The Sheriff report was received.

Motion by Keith supported by Eckloff to adopt the following resolution:

WHEREAS, the County of Keweenaw is interested in the continuing effort to update housing conditions for its low and moderate income homeowners; and

WHEREAS, said County Board of Commissioners has reviewed and approved the application for single-family rehabilitation funds through the Michigan State Housing Development Authority; and

WHEREAS, the County Board of Commissioners authorizes the Chief Elected Official to sign all forms as required;

THEREFORE BE IT RESOLVED, that the County Board of Commissioners authorizes the Western U.P. Planning & Development Region to submit the application for funding in the amount of \$100,000 through the Michigan State Housing Development Authority.

Jon Soper was present to discuss the Planning Commission. After resignations and members not attending meetings, the commission only has four active members. Keweenaw County needs an audit for 2008 and the State of Michigan has been contacted and will be sending a contract for Board approval in the near future. Bob Mikesch will send a contract to do the financial report.

Motion by Keith supported by Stubenrauch to send \$500 to KEDA for dues versus the \$750 that was requested. Board polled: Ayes: Eckloff, Stubenrauch, Keith, Fouts, Langdon. Nayes: None. Motion carried.
