OFFICIAL PROCEEDINGS KEWEENAW COUNTY BOARD OF COMMISSIONERS March 18, 2015

The regular monthly meeting of the Keweenaw County Board of Commissioners was held on March 18, 2015, 7:00 p.m. at the Courthouse, Eagle River, MI. The pledge was said at the 6:30 p.m. KML meeting prior.

Commissioners present: Randy Eckloff, Bob DeMarois, Don Piche, Ray Chase, Del Rajala.

The meeting was posted in the Courthouse on the bulletin board and the agenda for the meeting was posted on the door of the Courthouse.

Motion by Chase supported by Eckloff and unanimously carried to approve the agenda as presented.

Motion by Chase supported by DeMarois and unanimously carried to accept the minutes from the February 18, 2015 regular monthly board meeting as presented.

The Treasurer, Sheriff and Mine Inspector reports were received.

Time was allowed for public comment.

Motion by Eckloff supported by DeMarois to pay the approved and audited bills in the following amounts; General Fund=\$129,716.48 Construction Codes Fund=\$2,968.25 911 Fund=\$2,705.67 Law Library=\$333.50, Child Care Fund=\$1,002.00 County Veterans Trust Fund=\$0 Medical Care Fund=\$1,809.78. Board polled. Ayes: Eckloff, DeMarois, Chase, Piche. Nayes: None. Abstain: Rajala. Motion carried.

The Board decided to decline the membership with NACO (National Association of Counties) for 2015.

Motion by Chase supported by Eckloff and unanimously carried to approve the 2015 Keweenaw County Remonumentation Program and the listing for individual contracts which include Hein Surveying and Crampton Surveying Inc.

Motion by Chase supported by Rajala and unanimously carried to approve the change order submitted by OHM regarding the Courthouse entrance project. The change order states that the project will be completed by May 1, 2015.

Motion by Chase supported by DeMarois and unanimously carried to approve the Michigan State Housing Development Authority (MSHDA) Grant Agreement (MSC-2014-0741-HO) in the amount of \$86,718.

Motion by Eckloff supported by DeMarois and unanimously carried to accept the 50% forgivable mortgage and note as long as changes are made in the wording regarding how homeowners will pay back the 50% and WUPPDR was checking on the term of the mortgage and note being 50 years and whether that should be 40 years.

Motion by Chase supported by Rajala to adopt the following resolution:

WHEREAS, the Keweenaw County Board of Commissioners ("Board") is authorized under Michigan's Emergency Telephone Service Enabling Act, 1986 PA 32, as amended ("Act") and under authority provided by its Emergency Telephone Services Plan ("911 Plan") to make administrative findings regarding among other things, the 9-1-1 services provided within the 911 Plan's Service District;

NOW THEREFORE BE IT RESOLVED, that the Board hereby makes an Administrative Finding that Keweenaw County will adopt <u>Text to 9-1-1</u> and other enhanced 9-1-1 services otherwise known as <u>Next</u> <u>Generation 9-1-1 (NextGen 9-1-1)</u> in conjunction with Peninsula Fiber Network, LLC who has previously been defined as Keweenaw County's primary NextGen 9-1-1service supplier, employing a common network that enables all other service suppliers within the 9-1-1 Plan's Service District to be selectively routed and otherwise access the 9-1-1 system and the primary PSAPs identified in the Plan;

BE IT FURTHER RESOLVED, that Peninsula Fiber Network, LLC is authorized and directed to work with the 911 Plan's service suppliers, the Michigan Public Service Commission, State 911 Committee and State 911 Director and any other state, federal or local authority in order to effectuate and implement the provisions of this Administrative Finding.

BE IT FURTHER RESOLVED, that this Resolution shall augment, supersede, modify or replace any inconsistent prior resolution or motion;

BE IT FURTHER RESOLVED, that the County Clerk shall send a copy of this resolution and its Administrative Findings to each service supplier, PSAP, and emergency service provider within the County. Board polled. Ayes: Eckloff, DeMarois, Chase, Rajala, Piche. Nayes: None. Motion carried. (#15-1)
