The official meeting of the Keweenaw County Board of Commissioners held November 19, 2008, 6:30 PM at the Courthouse, Eagle River, MI, opened with the pledge of allegiance.

Motion by Turnquist supported by Eckloff and unanimously carried to approve the agenda.

The minutes of the November 5 meeting stood as read.

The Treasurer and Mine Inspector reports were received.

Richard Harrer reported the Keweenaw Mt. Lodge water system is not in violation, they do have an operation and maintanence manual.

Motion by Langdon supported by Stubenrauch to table a \$600 bill from Forsberg Appraisal Services and to pay the approved and audited bills from the following funds: General \$2,078,482.18; Construction Codes \$78.71; 911 Fund \$248.30; Economic Development \$1211.16. Discussion was held on Board members recruiting additional people for the Economic Development Commission and reactivating the Commission in January.

Motion by Langdon supported by Turnquist and unanimously carried to reappoint Debra Talvensaari to the Human Services Board, term expiring October 31, 2011.

Motion by Keith supported by Turnquist to transfer a \$15,000.00 appropriation to the Child Care Fund. Board polled. Ayes: All. Nayes: None. Motion carried.

Motion by Turnquist supported by Eckloff and unanimously carried to authorize the County Road Commission to plow the Mt. Greeley access road.

Motion by Langdon supported by Turnquist to amend the general fund budget – revenue add \$2,000 to donation, expenditure increase sheriff vehicle repair \$800. Board polled. Ayes: All. Nayes: None. Motion carried.

Time was allowed for public comment.

There being no further business motion by Turnquist to adjourn. Meeting adjourned sine die.
